

**TOWN OF NEWFIELDS BOARD OF SELECTMEN
MEETING MINUTES
TUESDAY, JANUARY 06, 2015**

Call to order at 7:00pm.

The Selectmen reviewed and signed:

- Checks Pd 12/31/14: Accts. Pay. Manifest - \$12,623.00

The Selectmen decided not to pay salary increases for the town employees until the March 2015 vote. If approved, the increases would be retroactive as of 01/01/2015.

The Selectmen read and voted on the 2015 Town Budget. Jamie made a motion to vote to approve the 2015 Town Budget of \$1,386,070.00(One Million, Three Hundred Eighty-Six Thousand , Seventy Dollars), seconded by Michael. All were in Favor (Aye, Aye, Aye) and the motion carried.
