

**TOWN OF NEWFIELDS BOARD OF SELECTMEN
MEETING MINUTES
TUESDAY, MAY 26, 2015**

Present: Selectmen: Michael Woodworth, Jamie Thompson and Chris Hutchins (absent). Others include: Dave Garvey, Scott Wachsmuth, Kent Lawrence and Dave Edgerly.

Call to order at 7:00pm.

The Selectmen reviewed and signed:

- Checks Pd 05/29/15: Accts. Pay. Manifest - \$ 2,448.37
Payroll Manifest - \$10,946.42

Dave Garvey met with the Board to discuss the 2013 Property Lien. Dave stated he is selling his property by the end of June and would need an additional 30 days to pay off the lien. Jamie made a motion to extend the payment time for Dave Garvey to pay the 2013 lien until June 30, 2015, seconded by Michael. All were in favor and the motion passed.

The Selectmen reviewed and approved the Health and Human Services Contributions for 2015 in the amount of \$6,800.00 to be paid on June 5th. Jamie made a motion to amend the budgeted amount, leaving \$200.00 in the Health Agencies Budget Line, seconded by Michael. All were in favor and the motion passed.

Kent Lawrence expressed his concern to the Board regarding the issue of the use of herbicides and/ or pesticides in the Town of Newfields, especially near the schools and children. The Board would look into this matter.

The Selectmen reviewed and signed the Property Tax Warrant for July 2015. Jamie made a motion to approve the July 2015 Property Tax Warrant to collect taxes, seconded by Michael. All were in favor and the motion passed.

William Meserve was nominated by the Planning Board as the Town representative to be appointed to the Rockingham Planning Commission. Jamie made a motion to appoint William Meserve as representative from the Town of Newfields to the Rockingham Planning Commission, seconded by Michael. All were in favor and the motion carried.

The Board reviewed the Notice of Submittal to the NH DES – Large Groundwater Withdrawal Permit Application Notification Form dated 5/21/2015 at the Epping Crossing Well Field –Wells D2 and E1, Epping, NH and the Planning Board and Conservation Commission receive this information as a PDF.

Dave Edgerly updated the Selectmen on the website:
